This agreement is made between **Shridev Suman Subharti Medical College, Dehradun**, run by Dr Jagat Narain Subharti Charitable Trust through its Administrative Officer Mr. Avinash Kumar Srivastava S/o Shri H.P. Srivastava Address- Subhartipuram, Kotda Santaur, Nanda ki Chowki, Dehradun (U.K) which is called as First Party hereinafter. ...

follows:-			-

- 1. That the first party is a Medical College located at Subhartipuram, Kotda Santaur, Prem Nagar, Dehradun Uttarakhand, imparting education in MBBS Course.
- 2. That the second party no. 1 is a student, who wants to take admission in the first party college for getting the studies in MBBS Course.
- 3. That the second party no. 2 is the father of the second party no. 1, who wants to get the admission of his son/daughter at the first party college.
- 4. That the second party no. 1 has been allotted a seat through counseling for admission in the first party college.
- 5. That, the Uttarakhand Government has provisionally fixed fee of the MBBS Course of the first party College as Rs. 5 lacs per year for the Management Quota and Rs. 4 lacs per year for the Government Quota candidates.
- 6. That whereas, the College has decided a fee of Rs. 18.0 lacs per year for the Management quota and Rs. 13.50 lacs per year for the Government quota candidates as the tuition fee.
- 7. That the final decision regarding the fee to be payable by the candidates is yet to be finally decided by the appropriate legal forum/the Hon'ble Court.
- 8. That the first party College is giving admission to the second party no. 1, who is the son / daughter of the second party no. 2 provisionally on the fee decided by the Government.
- 9. That however, the first party has informed the second Party no.1 and the second party no. 2 that the final fee shall be as per the order of the Hon'ble Court/Appropriate Legal forum.
- 10. That the second party no.1 & second party no. 2 have consented to abide by the decision of the Hon'ble High Court/legal forum and shall pay the fee decided by them.
- 11. That the second party no.1 & second party no. 2 shall be liable to pay the difference of the fee as decided by the Hon'ble Court/legal forum as and when demanded by the College.
- 12. That in case the second party no. 1 & second party no. 2 withdraws from the course at any stage before completion of the course, the second party no. 1 & second party no. 2 will be liable to pay the full course fee to the first party prevalent on the date of withdrawal.
